## <u>Charnwood Campus</u> - Update on the Sale of Business / Recapitalisation Process

The school and ELC at the Charnwood campus do not form part of the sale to CCM. As previously disclosed, its college operations were consolidated into the Lyneham campus on a temporary basis for Term 2. This arrangement has been made permanent under CCM, meaning college operations will not continue at Charnwood.

Throughout this period the Administrators have continued to operate the Charnwood ELC on a business-as-usual basis while conducting a search for a new operator. This search remains underway, and the Charnwood ELC will continue to operate at this time.
