#### Application to extend the convening period

On 23 August 2024, Richard Hughes and I, David Orr, were appointed Joint and Several Administrators (Administrators) of the Companies on 23 August 2024, pursuant to the provisions of Section 436A of the *Corporations Act 2001* (the Act).

## First meeting of creditors

On 4 September 2024, we held the initial meeting of the creditors for each of the Companies in accordance with section 436E of the Act (**First Meeting**). A copy of the minutes for each of the First Meetings are available upon request.

In accordance with Section 439A of the Act, the Administrators must convene a second meeting of each of the Companies' creditors (**Second Meeting**) by 20 September 2024.

At the First Meetings, I outlined the Administrators' intention to seek court orders extending the period to convene the Second Meetings with the view to:

- allowing sufficient time to finalise a sale and/or recapitalisation of the Companies;
- providing the necessary time to effectuate a Deed of Company Arrangement, should one be proposed by an interested party; and
- allowing the Administrators the necessary time to reach a more favourable outcome overall for the creditors of the Companies.

#### Application to extent the convening period

On 16 September 2024, the Administrators filed an application in the Federal Court of Australia seeking orders to extend the period to convening the Second Meetings of the Companies (Application).
